By signing below you acknowledge the following:

- Each guitar created by Baldacci Guitars is built by hand using materials that we have deemed suitable for use. Guitars are a wood product and as such, may reflect the characteristics of, including but not limited to: grain anomalies, pin/knot holes, and/or color variations. All lumber pieces used have been thoroughly inspected and any anomaly has been deemed to not affect any functionality of the instrument.
- Construction will begin once all necessary forms are completely filled out and the 50%, non-refundable deposit is received. The final 50% is due on or before completion. If the invoice is not paid in full within 30 days of completion, the guitar will be sold and no refund will be given.
- Our guitar construction uses a variety of machinery as well as human-led operations to achieve the end result. As such, any guitar leaving our shop has met our standard to do so. While artistic imperfections may be present, they will not affect the overall quality or performance of the instrument.
- Estimated delivery times are reliant on many factors and are subject to change without notice.
- Photos will be taken throughout the process. You may ask for photos at any stage of construction. If you DO NOT wish any photos of your custom instrument to be used for any promotional purposes, initial here _____
- If any changes become necessary, as deemed by either party, during the construction of the instrument, all construction will cease until a consensus is reached. A change form must be acknowledged and signed by both parties detailing the changes and acknowledging any risks in making specified changes before construction can resume.
- All Baldacci Guitars custom instruments are warranted against any defect that affects the overall functionality of the instrument unless it is a result of a change made during the process in which the risk was acknowledged.
- A custom guitar may require minor adjustments upon receipt. This includes but is not limited to: action adjustment, nut adjustment, truss rod adjustment, and/or minor fret leveling. These minor adjustments are NOT covered under warranty.
- If the functionality of the instrument is compromised, it is the purchaser's responsibility to notify Baldacci Guitars of the issue within 7 days of receipt. Depending on the necessary repair(s) instructions will be given on the course of action.
